

**Amendment and Extension of the Memorandum of Agreement (MOA)
Between the United States Coast Guard Auxiliary
And
Orion Safety Products, a/k/a Standard Fusee Corporation**

1. **PARTIES.** The Parties to this Amendment and Extension are the United States Coast Guard Auxiliary, (hereinafter, the "Auxiliary") and Orion Safety Products, also known as Standard Fusee Corporation, (hereinafter, "Orion").

2. **AUTHORITY.** This Amendment and Extension is authorized under the following provisions:

- a. Title 14 United States Code §§ 821-822
- b. U.S. Coast Guard Auxiliary Manual, Commandant Instruction M16790.1 (series)
- c. The Memorandum of Agreement between the United States Coast Guard Auxiliary and Orion Safety Products, a/k/a Standard Fusee Corporation, with effective date 16 May 2013.

3. **PURPOSE.** The purpose of this Amendment and Extension is to assure that all actions taken by members of the Coast Guard Auxiliary pursuant to the Memorandum of Agreement are in compliance with COMDTINST M16790.1 (series) (The Coast Guard Auxiliary Manual) and to extend the terms of the Memorandum of Agreement previously executed by the Parties.

4. It is Agreed by and between the parties hereto that the Memorandum of Agreement between the parties that became effective on the 16th day of May 2013, shall be, and the same hereby is amended and extended as follows:

A. The Auxiliary may distribute to the boating public, coupons for the purchase of boating safety equipment and/or services manufactured or offered for sale to the public by Orion in recognition of the actual observance of safe boating practices.

B. The terms of the Memorandum of Agreement will remain in effect until terminated by either party. Either Party upon thirty (30) days written notice to the other may terminate this Memorandum of Agreement.

C. Article 4, paragraph 1 subdivision d of the Memorandum of Agreement is amended to provide that the "Members Only" electronic portal which links to Orion's internal webpage established for Orion's Safety Awareness Program may be maintained on the website of the Coast Guard Auxiliary Association, Inc. All members of the Coast Guard Auxiliary are also members of the Coast Guard Auxiliary Association, Inc.

D. All other terms and conditions of the Memorandum of Agreement effective on the 16th day of May 2013 shall remain in full force and effect.

E. The Gratuitous Services Agreement signed by Orion on the 15th day of January 2013, and the Auxiliary on the 14th day of February 2013 shall remain in full force and effect for the duration of this Memorandum of Agreement and any extension thereof.

5. OTHER PROVISIONS. Nothing in this Agreement is intended to conflict with current law or regulation or the directives of the United States Coast Guard or Department of Homeland Security. If a term of this agreement is inconsistent with such authority, then that term shall be invalid, but the remaining terms and conditions of this agreement shall remain in full force and effect.

6. EFFECTIVE DATE. The terms of this Amendment and Extension will become effective on the date it is signed by the final signatory.
