

## PAYROLL ALLOTMENT DISCREPENCY FOR POSTING DATE OF SEPTEMBER 1, 2014

All Coast Guard, National Oceanic and Atmospheric Administration, and US Public Health Service retired payroll allotments sent to the vendors listed below and with a payment/posting date of September 1, 2014 did not process properly. The financial institutions received the monies, but the vendors were unable to post the payments to the members account.

The CG Pay & Personnel Center and US Treasury have identified the error and the programming issue affecting the September 1 allotment should be resolved by Tuesday 9 September. Each affected vendor has been contacted to inform them of the corrective action being taken.

We expect the October 1, 2014 and all future allotment payments to process without incident. This is a unique situation and we thank you for your patience.

This issue should be resolved by Tuesday September 9<sup>th</sup>. If you have any questions or concerns about your individual allotment, please contact the vendor that receives your allotment after that date.

We are fully focused on a quick resolution. When the solution has been executed, we will post updated information.
