Subj: ENLISTED SUPPLEMENTARY CLOTHING ALLOWANCE – MATERNITY UNIFORM

Purpose The purpose of this E-Mail ALSPO message is to announce a change to the amount of the Enlisted Supplementary Clothing Allowance (SUPP CMA), Rule 8 – *Enlisted member assigned to active duty or the selected reserve and required to wear the **maternity uniform**.*

Effective date and new amount Effective 1 July 2008, \$262.82 is the amount authorized to enlisted members assigned to active duty or to the selected reserve (SELRES) and required to wear the maternity uniform. For members who have received the pre-1 July 2008 amount, this amount remains in effect.

Policy guidance Reference (a) authorizes SUPP CMA to enlisted members who are assigned to duty where they are required to have special items or quantities of individual uniform clothing not normally required for the majority of enlisted members. This supplementary allowance is in addition to any other clothing monetary allowance.

The provisions of reference (a), Figure 3-24, Note 6 to Rule 8 remain in effect:

- *“Subsequent payment will not be authorized for more than one pregnancy within 3 years of the date of approval of earlier payments.”*

The change announced in this E-Mail ALSPO will be made to reference (b).
