ADDITIONALLY, REF B UPDATED THE ENLISTED WORKFORCE ON THE POTENTIAL FOR CHANGES TO THE ENLISTED SHOPPING LIST AS THE CG AWAITS FINAL AUTHORIZATION FOR THE FY11 BUDGET AND THE POTENTIAL DECOMMISSIONINGS THAT WERE INITIALLY PROPOSED.

REVISED TIME LINES:

- (1) 03 DEC 2010: PRI 1,2,3,4 AND SEA DUTY CANDIDATES E-RESUMES DUE WITH APPLICABLE COMMAND ENDORSEMENTS.
- (2) 25 JAN 2011: PRI 1,2,3,4 AND SEA DUTY CANDIDATES SLATED AND APPLICABLE POSITIONS CLOSED ON THE OS SHOPPING LIST.
- (3) 26 JAN 2011: RE-PUBLISH OS SHOPPING LIST FOR PRI 5 CANDIDATES, AND PRI 5 PERSONNEL NOT IN RECEIPT OF A SEA DUTY ASSIGNMENT FOR AY11. (4) 14 FEB 2011: PRI 5 E-RESUMES DUE WITH COMMAND ENDORSEMENT.
- (5) 15 FEB - 31 MAR 2011: PRI 5 SLATED.
- (6) 31 MAR 2011: ALL ORDERS ISSUED INCLUDING FLEET UPS AND EXTENSIONS.

B. DEPLOYED MBRS THAT ARE UNABLE TO MEET THESE DEADLINES SHALL NOTIFY THE APPROPRIATE ASSIGNMENT OFFICER BY EMAIL OR MSG AS NECESSARY.

2. ALL TOUR COMPLETE AND RECENTLY ADVANCED OPERATIONS SPECIALISTS SHOULD CONTINUE TO REVIEW DIRECT ACCESS FOR CHANGES TO THE OS AY11 SHOPPING LIST.

3. ALL MBRS WHO APPEAR ABOVE THE CUT FOR OSC, FROM THE MAY 2010 SWE, SHOULD BE PREPARED TO SUBMIT AN E-RESUME IN PREPARATION TO PCS DURING AY11. EACH MBR WILL BE EVALUATED ON A CASE BY CASE BASIS, THROUGH THE APPLICABLE OS ASSIGNMENT OFFICER, AND THEIR DESIGNATED COMMAND POC.

4. ANY OSC THAT WISHES TO VOLUNTEER FOR A SEA DUTY ASSIGNMENT SHOULD CONTACT CWO LUIS AMADOR BY EMAIL NLT 03 DEC 2010. ANY OSC WITH LESS THAN THREE YEARS OF RATED SEA TIME IS CONSIDERED TO BE A SEA DUTY CANDIDATE AND SHOULD LIST NUMEROUS CUTTERS ON THEIR E-RESUME.

5. THE OS ASSIGNMENT OFFICERS WILL NOTIFY ALL SLATED OPERATIONS SPECIALISTS FOR AN ASSIGNMENT TO A CUTTER BY PHONE CALL, EMAIL, OR ORDERS NLT 25 JAN 2011. PRIORITY FIVE OPERATIONS SPECIALISTS IN NON-RECEIPT OF AN EMAIL OR ORDERS TO A SEA DUTY ASSIGNMENT BY 25 JAN 2011 SHOULD RE-SUBMIT AN E-RESUME AFTER THE SHOPPING LIST IS RE-PUBLISHED ON 26 JAN 2011. ALL PRIORITY FIVE OPERATIONS SPECIALIST E-RESUMES ARE DUE NLT 14 FEB 2011.

6. MBRS SEEKING OCONUS ASSIGNMENTS ARE REQUIRED TO COMPLETE AN OVERSEAS PRE-SCREENING CHECKLIST IAW PERSMAN CHAPTER 4, SECTION H. COMMANDS SHALL ENDORSE THESE E-RESUMES ACCORDINGLY, AND STATE THE MEMBERS POTENTIAL TO SUCCESSFULLY SCREEN FOR AN OVERSEAS ASSIGNMENT.
