New Eight Digit PIN change

As of August 30, 2004



On Monday, August 30, 2004, a change to Employee Express (EEx) Signon Access will become effective.

EEx Users with less than an eight (8) digit EEx PINs will be forced to change their EEx PINS to a minimum of eight (8) digits.

This EEx change is mandatory in the effort to improve EEx security access.

Example: Old PIN "1234". New PIN "12341234".
