Status updates via the Physician Report form shall be provided to CG PSC-RPM-3 every 30 days, at the time of extension request or when member is deemed Fit for Full Duty (FFD) (only a military medical officer can render an official duty status).</li> <li>4. Failure to comply with these requirements will result in suspension or termination of benefits and possible recoupment.</li> <li>5.
