- **ALCOAST 0356/16 – Reserve Enlisted high Year Tenure**
- **R-HYT total Time-In Service (TIS)**
- **All R-HYT PGPs are stated in total years of military service (Active and Reserve from any Service Component).**
- **Not the same as Total Qualifying Service (TQS), which counts years that qualify toward a non-regular retirement.**

EXAMPLE

- 10/02/91 – 10/05/99 Prior Military Service, 8+ YOS
- 01/29/02 – Present USCG Reserve, 14+ YOS

TOTAL MILITARY SERVICE 22+ YOS

2016-2017 HYT PGP – E4 (20 YOS)!!!

Member only had 15 “Creditable” years of service for Non-Regular Retirement...Not Eligible!!!
