2. All officers who have applied should, at their earliest convenience, obtain a physical that meets retention standards and is recorded on a DD-2697 prior to separation. The retention physical is required before an accession can be completed to transition an officer into the Reserve. Applicants should ensure that their personal contact information, (home address, personal e-mail, cell phone number, etc.), are updated in Direct Access (DA).

3. All applicants should review section 1.G. of REF A, section 1.A. and 1.E. of REF C to determine eligibility. Officers still on active duty and officers that have already separated from the Coast Guard must apply in writing and forward their requests to:

4. All applicants may submit letters of communication to the Panel in accordance with section 3.A.4.f. and 3.B.3.c. of REF A, paragraph 9.e. of REF D, and forward scanned copies, no later than 8 Feb 2015, to: arl-pf-cgpsc-rpm-boardspanels(at)uscg.mil.

5. All officers under consideration are encouraged to review their official Electronically Imaged-Personnel Data Record (EI-PDR) to verify their record prior to panel convening.
