Application Deadlines

- Summer Internships: due January 15th
- Fall Externships: due May 1st
- Spring Externships: due October 1st

Applications open after the preceding application cycle has closed.

Eligibility

- Be a United States citizen of good moral character
 - Foreign nationals are not eligible. Dual citizens of the U.S. and another country may apply. Dual citizenship may impact the security screening that is required prior to starting the internship/externship.
- Be a law student enrolled in an American Bar Association (ABA)accredited school with at least one year completed by the time you start the internship/externship

Experience

- Draft briefs, conduct legal research, assist with depositions, or help an attorney prepare for a trial.
- Work alongside civilian attorneys, judge advocates, paralegals, and military judges.
- Gain valuable insight on the Coast Guard and its legal community.
- Receive training and feedback on your work.
- Learn what it's like to be a Coast Guard judge advocate or civilian attorney.

Programs

CGJAG offers full-time summer internships and part-time or full-time semester externships.

- Internships and externships are in person.
- Internships and externships are unpaid, and interns must pay for all lodging and travel expenses.
- There are no physical fitness or medical requirements to do the internship/externship.

Summer Internship

Start date: first Monday in June

Length: 10 weeks

• Hours: full-time

Fall or Spring Externship

- Start date: flexible, depending on school externship program requirements
- Length: school semester (typically 14-16 weeks) depending on school externship program requirements
- Hours: full-time or part-time, dependent on credit requirements
