CONSENT ORDER APPROVING SETTLEMENT AGREEMENT

The United States Coast Guard (Coast Guard) served Zymiry Jemel Price (Respondent) with a Complaint on March 6, 2024. On April 4, 2024, the Coast Guard filed a Motion for Default Order due to Respondent's failure to submit a timely Answer, as defined by 33 CFR § 20.308(a). Conversely, the parties filed a Motion for Approval of Settlement Agreement and Entry of Consent Order, on May 7, 2024, stipulating the case be approved as settlement under 33 C.F.R. § 20.502. Since the Coast Guard now moves to enter into a Settlement Agreement with the Respondent, Coast Guard filed a Notice of Withdrawal for Motion for Default, on May 9, 2024, thereby retracting the Motion for Default Order, as moot and resolving the matter at issue.

I have carefully reviewed the terms of the Settlement Agreement and find it is fair and reasonable and in substantial compliance with the requirements of 33 C.F.R. § 20.502.

Upon consideration of the record, **IT IS HEREBY ORDERED** that:

1. Coast Guard's Notice of Withdrawal for Motion for Default is **GRANTED**.
2. The stipulated Settlement Agreement is **APPROVED** in full and incorporated herein by reference. This Consent Order shall constitute full, final, and complete adjudication of this proceeding.


