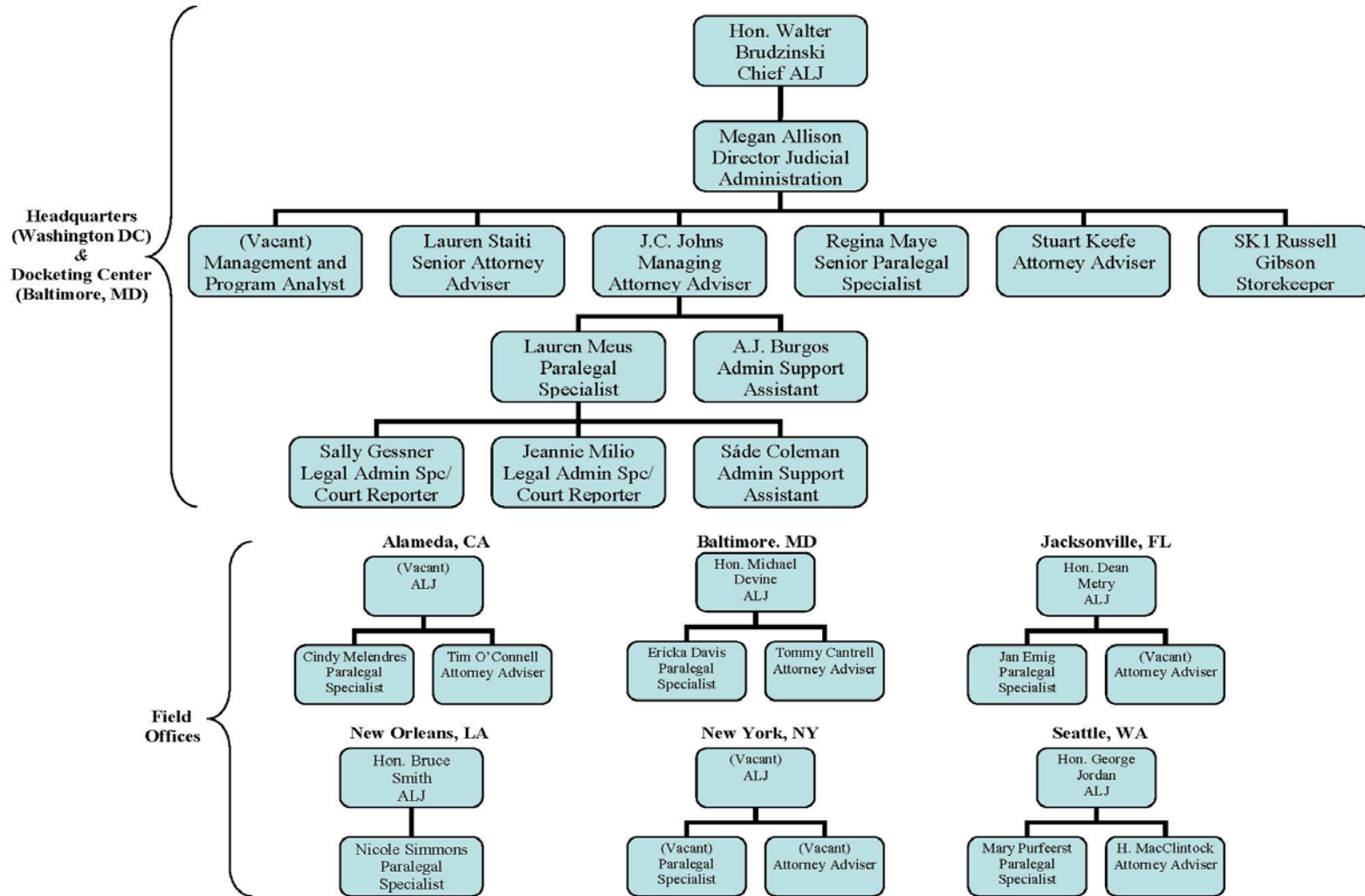




ALJ Docketing Center

▶ **Function:**

- The centralized office which accepts the initial filings of cases from the agency & assigns cases to the field judges.
- Maintains and archives closed cases files for the Coast Guard.
- Provides assistance to respondents, respondent representatives, and the agency on the proper filing of documents and status reports.

Types of Cases we Process

- ▶ Suspension and Revocation of U.S. Coast Guard (USCG) Credentials
- ▶ Non-Coast Guard Cases:
 - Transportation Security Administration (TSA):
 - Hazardous Material Endorsement (HME)
 - Transportation Worker Identification Card (TWIC)
 - Civil Penalties against individuals and airline
 - Aviation Worker (AVW)
 - Airmen Certificate
 - Bureau of Industry Security (BIS)
 - Merit Systems Protection Board (MSPB)
 - Internal Revenue Service (IRS)
 - Department of Homeland Security (DHS):
 - Freedom of Information Act (FOIA) Appeals
 - Debt Collection Cases (Immigration and Customs Enforcement (ICE), Customs and Border Patrol (CBP), and U.S. Custom Immigration Service)

Typical S&R Case

Docketing Center Involvement

- ▶ Complaint filed with ALJ Docketing Center by the USCG
 - Docketing Center reviews for sufficiency
 - Answer filed with ALJ Docketing Center by Mariner
- ▶ ALJ Docketing Center assigns case to Field ALJ
 - Motions Practice
 - Proposed Exhibits
 - Proposed Witnesses
 - Discovery Requests
 - Hearing
 - Decision
 - Findings of Fact specific to the case
 - Detailed legal analysis
 - Sanctions, if any are imposed
- ▶ Case returned to ALJ Docketing Center
 - Appeal is filed, case file forwarded to Commandant for review
 - Historical cases are sent to the National Archives

Search Tips

▶ Search Current Unit

- Click “search current unit” to search just ALJ website.
- To search all USCG website (including CDOAs), do not click.

▶ Advanced Search: This Exact Phrase

- To find cases involving “refusal to test”
 - Type in: “refusal to test”
 - This brings up 28 hits
- To find cases involving “refusal to test” and Judge Fitzpatrick
 - Type in: “refusal to Test” AND Fitzpatrick
 - This brings up 4 hits
- To find cases involving “refusal to test” or “refusal to submit”
 - Type in: “refusal to test” OR “refusal to submit”
 - This bring up 77 hits.

▶ Advanced Search: None of These Words

- To find cases involving “refusal to test” that don’t involve cocaine.
 - Type in: “cocaine” in the None of These Words function
“refusal to test” in This Exact Phrase function
 - This brings ups 24 hits.
