

## **NAVY DEFENSE SERVICE OFFICES**

1. This is a list of Navy Defense Service Offices. Coast Guard members may use these offices to get legal advice for disciplinary or administrative issues for which they are not entitled to, or not yet assigned, a detailed military defense counsel. The most common issues are:
  - a. Pre-NJP/NJP Appeals
  - b. Administrative Separation/Board of Inquiry
  - c. Adverse Evaluation
  - d. Complaint of Wrongs (Art 138)
  - e. Under Investigation (by CGIS/Police/Command)
  - f. Security Clearance Revocation
  - g. Board for Correction of Military Records
  - h. Court-Martial charges preferred but no defense counsel assigned yet.
2. Coast Guard members facing these types of issues should not call the District Legal Office, local SJA, LSC, etc.
3. Services are provided in person or by phone. Members should call or visit the office geographically closest to them. Those visiting in person must be in uniform. All those seeking services should be prepared to fill out and return intake forms and to provide relevant documents (notice of intent to separate, CG-4910, etc.)
4. DSOs do not provide legal assistance (e.g. wills, powers of attorney, landlord/tenant issues), nor do they provide services to non-servicemembers such as dependents.
