REMOVE TONNAGE LIMITATION	MLD-WI 5434-02(01)	
For mariners who were grandfathered with tonnage to match the inspected deck officer endorsement (Example: Master 100 GRT inspected with Master T/V 100 GRT). Not to be used for limited geographic endorsements		
1. 24 months service as Master or Mate (Pilot) of towing vessels, and 2. Completion of AMS exam or an exam for service on vessels of at least 200 GRT.		
MASTER OF TOWING VESSELS (LIMITED)	46 CFR	
1080 days of service OF WHICH: 1. 540 days must be on towing vessels as limited Apprentice Mate AND 2. 90 days must be on a particular route AND 3. Either hold a completed TOAR OR complete an approved course. CANNOT be issued for Near Coastal or Oceans waters or greater than 200GRT per 46 CFR 11.463(c). Limited endorsement will have 200 GRT limitation for GL/IN and WR.	11.464	
Mariners holding an endorsement as Mate (Pilot), may have Master of Towing Vessels (limited) added to their MMC for a limited local area within the scope of their current route.	11.464	
Ensure REC Chief validates existing route and verifies current approval per OCMI authorization. Verify if current approval in Local Limited Folder – if not, obtain a copy through REC.		

HOLDS MASTER STEAM/MOTOR MORE THAN 200 GRT	46 CFR	
May operate towing vessels within any restrictions on their endorsement if they have 1. 30 days of training & observation on towing vessels on a particular route; AND 2. Either hold a completed TOAR OR complete an approved course. Note: Western Rivers requires 90 days of observation and training, TOAR or approved course and <u>must be endorsed on credential</u>; EXCEPTION: If operating on LMR Pilotage waters (MM 236 and below), not required to hold WR endorsement but must hold Master of T/V for other routes/waters.	11.464 15.610(b)	
Requirements for Adding A Route		
If holding an endorsement as Master Greater Than 200 GRT: Western Rivers – 90 day of observation and training; AND WR TOAR; AND evidence of Apprentice Mate WR course/testing. Inland – 30 days of observation and training; AND Inland TOAR; AND evidence of Apprentice Mate Inland course/testing. Near Coastal/Oceans – 30 days of observation and training; AND NC/Oceans TOAR; AND evidence of Apprentice Mate NC/Oceans course/testing. If holding an endorsement as Master T/V: 90 days on requested route, appropriate TOAR and exam to add route	11.464
