2. All officers who have applied should, at their earliest convenience, obtain a physical which meets retention standards recorded on a DD-2697 prior to separation. The retention physical is required before an accession can be completed transitioning an officer into the Reserve. Also they should ensure that their personal contact information, (home address, personal e-mail, cell phone number, etc.), are updated in Direct Access (DA).

3. All applicants should review section 1.G. of REF A, section 1.A. and 1.E. of REF B to determine eligibility. Officers, still on active duty, wishing to apply for a Reserve commission should go to the following website for instructions on how to apply via DA: [www.uscg.mil/rpm/rpm1/R2R.pdf](http://www.uscg.mil/rpm/rpm1/R2R.pdf). Officers that have already separated from the Coast Guard must apply in writing and forward their requests to: [arl-pf-cgpsc-rpm-boardspanels@uscg.mil](mailto:arl-pf-cgpsc-rpm-boardspanels@uscg.mil). All officers wishing to apply should submit their application NLT 30 Apr 2014.

4. All applicants may submit letters of communications to the Panel in accordance with section 3.A.4.f. and 3.B.3.c. of REF A and forward scanned copies, no later than 12 May 2014, to: [arl-pf-cgpsc-rpm-boardspanels@uscg.mil](mailto:arl-pf-cgpsc-rpm-boardspanels@uscg.mil).
