Announcing DOI's Leadership Effectiveness Exchange (LEE): Leaders Helping Leaders to Manage the Challenges Posed by the Transition & Other Situations

Separate workshops will be held for Federal Executives, Managers and Supervisors.

The Federal Consulting Group, which is part of the US Department of the Interior, will be continuing for the fourth year its highly successful Leadership Effectiveness Exchange workshop.

The LEE is an inter-agency workshop which allows Federal leaders to help each other, as peers, to find new approaches and strategies for meeting difficult leadership challenges. To ensure a peer environment, each LEE is restricted to a specific level of Federal leadership, i.e., Executive, Manager or Supervisor. All sessions are confidential and table groups will be composed of an inter-agency mix.

Note: The LEE for Executives workshop meets the requirement requiring Federal Executives to attend an executive level training event as part of their EDP.
